# FCC: New form 610

The new FCC form 610 is now available from the FCC's forms contractor. The FCC has ordered the destruction of all previous versions of the form. As of January 1,1998, the FCC will accept only the new form 610 for all filings. Forms 610A and 610B also have been amended. The major changed in the new form is a certification that says the applicant has read and will comply with the new RF radiation safety rules that begin 1/1/98
